1. Annual Dues

- Membership with the Pennsylvania Chapter is on a calendar (January 1 to December 31) basis; annual dues are payable in full by January 31.
- For new members, annual dues are prorated quarterly. Companies joining ACPA/PA in the fourth quarter shall pay annual dues in full for the following year, but their membership begins immediately.

2. Local Allied Materials/Equipment Members

- Companies that market, sell or distribute products predominately in Pennsylvania (and/or anywhere throughout a neighboring affiliated Chapter/State that is located within 60 miles of the primary place of business of the member) are designated as LOCAL MATERIAL or LOCAL EQUIPMENT members and may join the *Pennsylvania Chapter* without joining ACPA/National.
- The *Pennsylvania Chapter* will collect and forward ACPA/National dues for those companies that elect to join ACPA/National through ACPA/PA.

3. National Allied Materials/Equipment Members

- Companies that choose to join the *Pennsylvania Chapter* and that do business within multiple Chapter/States must join both a local Chapter/State and ACPA/National. These companies are designated as ACPA/National MATERIAL members or ACPA/National EQUIPMENT members.
- After joining, all subsequent dues will be invoiced directly by ACPA/National for the minimum dues in the company’s Sales Category tier (see ACPA/National dues structure). ACPA/National will collect and forward dues to the *Pennsylvania Chapter* and/or other Chapter/State(s) that are selected by the ACPA/National

4. Allied Services Members

- ALLIED SERVICES companies that choose to join the *Pennsylvania Chapter* also have the option to join ACPA/National. The *Pennsylvania Chapter* will collect and forward ACPA/National dues for those companies that elect to join ACPA/National through the *Pennsylvania Chapter*
- READY-MIXED CONCRETE firms may join ACPA/PA as an Associate Industry member.

5. Effective Dates

- ACPA/PA dues approved August 31, 2022, are effective January 1, 2023. ACPA/National dues that are shown above were in effect for 2022; ACPA/National annual dues to be reevaluated later for 2023.
